It is the practice of the City of Yellowknife to advertise all vacancies for boards and committees. The City has advertised a vacancy on the Community Advisory Board (CAB) on Homelessness in the Capital Update, the City's website and social media sites.

Council policy, resolution or goal include:

Council Goal #2 Delivering efficient and accountable government.

Motion #0459-96, as amended by #0460-96, #0462-96 and #0273-09:

"The following policy be adopted with respect to appointments to municipal boards and committees:

- The maximum consecutive years that an individual may serve on any one board or committee is six.
- ii) Individuals who have served the maximum six-year period on one municipal board or committee shall be eligible to be appointed to another board or committee.
- iii) No individual shall be precluded from serving concurrent terms on more than one municipal board or committee.
- iv) Notwithstanding that an individual appointee has served less than six years on a particular board or committee, Council may, after the expiration of the first or subsequent terms of that appointee, advertise for applicants to fill a vacancy on that board or committee.
- v) Notwithstanding clause (i.) of this policy, should the City receive no applications to fill a vacancy on any particular board or committee, the six year maximum limitation may, at the discretion of City Council, be waived.
- vi) Should the City receive no applications to fill a vacancy on any particular board or committee, City Council may appoint a member of the public at their discretion.

Applicable legislation, by-laws, studies, plans include: Council Procedures By-law No. 4975, as amended.

Legislation

Section 122 of Council Procedures By-law No. 4975, as amended, states:

Special Committees of Council

- 122. Where Council deems it necessary to establish a special committee to investigate and consider any matter, Council shall:
 - (1) name the committee;
 - (2) establish terms of reference;
 - (3) appoint members to it;
 - (4) establish the term of appointment of members;
 - (5) establish requirements for reporting to Council or a standing committee; and
 - (6) allocate any necessary budget or other resources to it.

Procedural Considerations

All appointments to Special Committees must be approved by Council.

The composition of the Committee was structured so that various segments of the community are represented.

The Committee members will assist the City in an advisory capacity regarding homelessness issues within the municipal boundaries of the City of Yellowknife. Appointing a full complement of Members will ensure that the work of the committee is completed in a timely fashion.

Committee recommends that Council appoint William Greenland, a representative who has lived experience of homelessness, to serve on the Community Advisory Board on Homelessness (CAB) for a two-year term commencing March 14, 2023, and ending March 13, 2025.

MEMORANDUM TO COMMITTEE

ISSUE: Whether to approve the reallocation of a portion of 2022-23 Reaching Home

remaining funding for the 2022/2023 fiscal year.

RECOMMENDATION:

That Council reallocate \$1,318,864.34 of the 2022-2023 Reaching Home - Canada's Strategy to End Homelessness funding to the Government of the Northwest Territories (GNWT) for permanent supportive housing and/or transitional housing or other eligible capital activity in Yellowknife.

BACKGROUND:

On February 6, 2023, Council approved the recommendation from the City of Yellowknife Community Advisory Board on Homelessness (CAB) to allocate the remaining Reaching Home 2022-23 funding of \$1,468,864.34 to (a) Transition of Aspen Apartments into non-market housing (for capital and O&M costs): \$1,318,864.34; and (b) Salvation Army's Bailey House in alignment with Reaching Home Directives: \$150,000.00.

On March 6, 2023, Housing NWT (HNWT) confirmed to the City that it had adequate funds from other sources to be able to renovate Aspen Apartments into non-market housing. HNWT has suggested alternate use for the \$1.3M which would meet both Reaching Home requirements as well as community needs within Yellowknife.

HNWT is proposing to use the \$1.3M transfer through the City of Yellowknife from the Reaching Home funding to support GNWT's implementation of the Transitional Housing for Addictions Recovery Program (THARP) in Yellowknife. HNWT reviewed the THARP program requirements with the Department of Health and Social Services (HSS) and determined that a mixed-occupancy model for Aspen Apartments, which included both transitional housing for clients recovering from addictions and general public housing, was an incongruous use. To more effectively support addictions recovery, the \$1.3M would be used by HNWT to develop an asset to support the THARP program — either a retrofit of an existing 6-plex or a new build 6 bedroom facility with common living spaces.

Goal #3: Ensuring a high quality of life for all, including future generations.

Objective 3.3 Work with partners to address pressing social issues.

Action 3.3.2 Focus on bringing partners and funding to support the implementation of the City's

That Council approve the recommendation from the City of Yellowknife Community Advisory Board on Homelessness (CAB) to allocate the remaining \$1,468,864.34 of 2022-2023 Reaching Home - Canada's Strategy to End Homelessness funding as follows:

- 1. Transition of Aspen Apartments into non-market housing (for capital and O&M costs): \$1,318,864.34; and
- 2. Salvation Army's Bailey House in alignment with Reaching Home Directives: \$150,000.00.

APPLICABLE LEGISLATION, BY-LAWS, STUDIES, PLANS:

Everyone is Home – Yellowknife's 10 Year Plan to End Homelessness.

CONSIDERATIONS:

Existing Programs/Services

CAB has previously allocated \$1,219,953 of the 2022/2023 funding as follows:

- Housing First for Youth \$175,000 Homebase Yellowknife;
- Housing First for Families \$376,000 YWCA;
- Housing First for Adults \$350,953 Yellowknife Women's Society;
- Prevention and Shelter Diversion \$219,000 Homebase Yellowknife; and
- Indigenous Case Management \$ 99,000 Arctic Indigenous Wellness foundation.

As well, CAB determined, and Council subsequently approved, the allocation of \$2,064,562 in 2023-24 Reaching Home - Canada's Strategy to End Homelessness funding as outlined below.

- 1. Housing First for Youth: \$393,893;
- 2. Housing First for Families: \$594,893;
- 3. Housing First for Adults: \$569,846;
- 4. Prevention & Shelter Diversion Youth: \$100,000;
- 5. Prevention & Shelter Diversion Adults: \$100,000;
- 6. Prevention & Shelter Diversion Families: \$100,000;
- 7. Prevention & Shelter Diversion Seniors: \$100,000; and
- 8. Indigenous Case Management: \$ 105,930.

There remains \$404,854 in 2023-24 Reaching Home funding to be allocated by CAB and approved by Council.

ALTERNATIVES TO RECOMMENDATION:

As the deadline to allocate the 2022-23 funding is March 31, 2023, there are no alternatives to the motion at this time.

RATIONALE:

The reallocation of funds previously identified for the renovation of Aspen Apartments to a second project, given HNWT's confirmation of adequate funds to complete Aspen, results in a broader impact of the Reaching Home 2022-23 funding allocation. This funding would now support not one but two projects which will expand the both the non-market housing stock and the social/transitional housing stock in Yellowknife for a broader client base.
