Committee noted that since taking office in November 2022, Council has worked to confirm its mission, vision, principles and high level strategic directions that are supported by focus areas and proposed key initiatives for Council's term of office. On May 15, 2023, Council approved the draft 2023-2026 Strategic Directions release to the public for engagement and review and subsequently approved the Strategic Directions on June 26, 2023.

These strategic directions reinforce and complement the core services and mandated responsibilities that the City continues to uphold and deliver upon, while providing key areas of focus that Council believes are important for the community over the next four years. Confirming strategic directions can (a) ensure transparency for Council's key high-level priorities, (b) focus on the steps required to get there and (c) guide Council when making decisions regarding the allocation of resources.

Administration has developed an Implementation Plan that can advance Council's Strategic Directions, ensuring that those directions identified as a priority by Council members (through an e-survey conducted by the Mayor in October 2023) are highlighted for immediate/priority action.

Committee noted that Council's policies, resolutions or goals include:

Resolution 0091-23 That Council approve the 2023-2026 Council Strategic Directions

Committee noted that applicable legislation, by-laws, studies or plans include Council's Strategic Directions 2023-2026.

Implementation

Over this Council's term of office, Administration will undertake a range of actions intended to advance and/or achieve Council's Strategic Directions and priorities. Annually, Administration will report out on actions taken and progress made, including priorities for the upcoming year.

Committee noted that Council's Strategic Directions provide direction and focus for the future of the City of Yellowknife and will help guide Council decision-making regarding priority setting, resources and budget allocations. Council's Strategic Directions will inform the work of Administration as it works to advance and achieve Council's goals. An annual review to mark progress and ensure clear priorities for the upcoming year will confirm alignment with current context and emerging issues.

Committee suggested the following changes and left it with Administration to finalize:

Continuing to strengthen relations with Indigenous Governments and peoples:

- Strike: Indigenize Space Banners.
- Strike: Engagement with Indigenous governments.
- Strike: Joint Economic Development Strategy add specific items that we want to see done (if they haven't made this list yet).



 Strike: Reconciliation Action Plan, and replace with specific actions/deliverables for 2024.

Setting the context and foundation for a fulsome continuum of housing options, from social to market to workforce accommodation:

- Strike: Develop a new 10 year plan to end homelessness.
- Add: Work with GNWT and Community Partners to support implementation in Yellowknife of the GNWT's "A Way Home: A Comprehensive Strategy to Address Homelessness in the Northwest Territories".
- Strike: Polytechnic Planning for Student Housing.
- Strike: Disposal of 50/50 lot.

Providing affordable and diverse recreation and arts opportunities for residents:

- Update: the Arts & Culture implementation plan date to 2024.
- Strike: Programs that cater to all socio-economic aspects of the community. Unless there's a specific action that we're looking to take to address this.
- Change: "Non-commercial art gallery space" to "Non-commercial art gallery space governance" and change the date to "2024".
- Strike: Accessible playgrounds & components through the City.
- Strike: Increased recreation programs and activities through collaboration with community groups. Unless we have a specific action that we're looking to do over the next three years.
- Move RIMP Building assessment and renewal to 2024.
- Strike: Facility booking & program software replacement.

Pursuing diverse community engagement methods:

• Strike: "Council-led" initiatives – until we come up with a concrete action.

Supporting design standards that are multi-modal including recognizing Yellowknife's advantages as a winter city:

- Break each of these down with a start and end date.
 - Development & Design Standards ongoing development/expansion to include:
 - Winter City/snow removal design best practices.
 - Traffic calming best practices.
 - Pedestrian and Bicycle options.
 - Roads & sidewalks/multi-purpose trails.



Providing public transit that meets users needs:

Update "Implementation of revised transit routes including:" – Either delete this

Advocating for enhanced outreach and social support services:

- Strike "Advocacy with GNWT re: social issues, addictions and mental health." This is currently business as usual; add a specific action.

 Strike: Applications for land required for municipal infrastructure and development.

Completing land development tools and strategies that support growth readiness:

Change Kam Lake 2.0 timeline from "2025" to "2024" (include start and end date).

Sustaining infrastructure capacity for future growth:

- Strike: Lift Station #1
- Strike: "Implementation of Annual Capital Plan".
- Strike: Water Submarine Line items, but add "Water Submarine Line: Revisit the evaluation matrix completed in 2018 with current data."
- Add: "Implement AAA recommendations (including updating Emergency Evacuation Framework)".
- Add: "Host a public information/education session in the spring on evacuation preparedness".

Supporting all aspects of tourism and visitor services, including the accommodation levy and creation of the destination marketing organization:

- Update & Change VC Governance Structure to Visitor Centre Governance Structure and change the timeline to 2024.
- Strike: Lobby GNWT to rebrand YK Airport.
- Modify timeline of Tourism Experience of Tomorrow move to 2026.

Implementing and renewing strategic economic diversification options:

- Change the timeline for "Establish a business accelerator/incubator in YK" from 2024 to 2025 or 2026.

Aligning with regional and territorial economic opportunities:

It is the practice of the City of Yellowknife to advertise all vacancies for boards and committees. The City has advertised a vacancy on the Community Advisory Board (CAB) on



Homelessness in the Capital Update, the City's website and social media sites.

Committee noted that Council's policies, resolutions or goals include: Council Goal #1 People First

Motion #0459-96, as amended by #0460-96, #0462-96 and #0273-09:

"The following policy be adopted with respect to appointments to municipal boards and committees:

- i) The maximum consecutive years that an individual may serve on any one board or committee is six.
- iii) Individuals who have served the maximum six-year period on one municipal board or committee shall be eligible to be appointed to another board or committee.
- iv) No individual shall be precluded from serving concurrent terms on more than one municipal board or committee.
- v) Not with standing that an individual appointee has served less than six years on a particular board or committee, Council may, after the expiration of the first or subsequent terms of that appointee, advertise for applicants to fill a vacancy on that board or committee.
- vi) Notwithstanding clause (i.) of this policy, should the City receive no applications to fill a vacancy on any particular board or committee, the six year maximum limitation may, at the discretion of City Council, be waived.
- vii) Should the City receive no applications to fill a vacancy on any particular board or committee, City Council may appoint a member of the public at their discretion.

Committee noted that applicable legislation, by-laws, studies or plans include Council Procedures By-law No. 4975, as amended.

Legislation

Section 122 of Council Procedures By-law No. 4975 states:

Special Committees of Council

- 122. Where Council deems it necessary to establish a special committee to investigate and consider any matter, Council shall:
 - (1) name the committee;
 - (2) establish terms of reference;
 - (3) appoint members to it;
 - (4) establish the term of appointment of members;
 - (5) establish requirements for reporting to Council or a standing committee; and
 - (6) allocate any necessary budget or other resources to it.

Procedural Considerations

All appointments to Special Committees must be approved by Council.

The composition of the Committee was structured so that various segments of the community are represented.



Committee noted that the Committee members will assist the City in an advisory capacity regarding homelessness issues within the municipal boundaries of the City of Yellowknife. Appointing a full complement of Members will ensure that the work of the committee is completed in a timely fashion.

Committee recommended that Council appoint Nicholas Sowsun, member at large, to serve on the Community Advisory Board on Homelessness (CAB) commencing November 28, 2023 and ending November 27, 2025.

Committee noted that this matter will be considered at that evenings Council meeting.

BACKGROUND:

Geoffrey Thomas Pothier has been hired as a By-law Officer for the City of Yellowknife. The *Cities, Towns and Villages Act* states that Council may appoint By-law Officers to enforce any or all of its by-laws.
